Once loaded, we kindly ask you to place **TWO** new pheromone tobacco beetle traps in each container (front and back), clearly visible and easy accessible upon opening doors. After fumigation but prior to shipment. Kindly follow instructions on the trap for folding and the trap is to be marked with usage date accurately.
