Hope all going well

Nice to hear that it is going to be a good harvest and increased volume is expected to be shipped

Pls note that Piraeus Terminal has increased all terminal costs (THC, Lift On/Off, ISPS, WEIGHTING, PORT STORAGES etc.)

You can verify it with the increased destination FREE OUT/DTHC that shipping lines will quote you.

e.g MSC increased them from EUR 351/CONTR + EUR 10/DO to EUR 381/CONTR + EUR 10/DO

MAERSK is charging about EUR 403/CONTR

From our side in order to support and boost your sales for our mutual interest we managed to squeeze the costs and not only absorb the increased cost of Piraeus Terminal but also to slightly decrease total cost.

Only the port storages we have to charge at cost as per updated tariff of Piraeus Terminal (see attached)
