

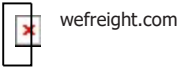
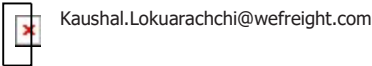
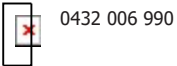

Hi Kaushal, good evening! How are you?

First of all, thank you for both shipments you arranged with Luisa.

I'm coordinating with her regarding these, and I'd like to share some updates so we can decide how to proceed. If you don't mind, I'm starting a new thread since both shipments are on the same route, only with different shippers. Once we've made the decisions, we can return to the original messages to continue the follow-up there.

Equipment availability:

ZIM: no containers available, only in Santos

Cosco: no containers available along the entire Brazilian coast

MSC: no containers available, not even in Santos

CMA: only 4 containers available in Rio de Janeiro

So, the best (and only) scenario is to load via Rio de Janeiro.

Cargo readiness:

Shipment 1

Shipper: Naturale Granitos

Update: I called them since they were not replying to our emails. Ms. Ariane will check with the sales team if the cargo is ready and will get back to us soon.

Condition: They can accept loading via POL Rio de Janeiro, with an additional cost of **USD 750** on top of the commercial invoice to the consignee.

Shipment 2

Shipper: Gramazini

Update: Cargo is ready. The shipper can accept loading via POL Rio de Janeiro, with an additional cost of **USD 1,600** on top of the commercial invoice to the consignee. I'm checking if this cost can be reduced.
