Die ADSp 2017 weichen in Ziffer 23 hinsichtlich des Haftungshoehstbetrages fuer Gueterschaeden (§ 431 HGB) vom Gesetz ab, indem sie die Haftung bei multimodalen Transporten unter Einschluss einer Seebefoerderung und bei unbekanntem Schadenort auf 2 SZR/kg und im Uebrigen die Regelhaftung von 8,33 SZR/kg zusaetzlich auf 1,25 Mio. € je Schadenfall sowie 2,5 Mio. € je Schadenereignis, mindestens aber 2 SZR/kg, beschaerzken. In Ergaenzung der Regelungen von Ziff. 23 ADSp 2017 gilt Folgendes: Thermottraffic haftet nicht fuer Schaeden infolge von Verlust, Beschadigung und/oder Verzoegerungen, die durch ein Verschulden seiner Leute und Schiffsbesatzung bei der Fuehrung oder sonstigen Bedienung des Schiffes verursacht werden („nautisches Verschulden“). Dies gilt jedoch nicht bei der Durchfuehrung von Massnahmen, die ueberwiegend im Interesse der Ladung getroffen wurden, oder durch Feuer oder Explosion an Bord des Schiffes verursacht werden. Im Uebrigen ist die Haftung von Thermottraffic fuer Verzoegerungen, die auf der Seestrecke eintreten, auf den dreifachen Betrag der Fracht begrenzt. Die vorstehenden Haftungsbeschaerzungen fuer nautisches Verschulden und bei Verzoegerungen auf der Seestrecke gelten nicht in Faellen eines qualifizierten Verschuldens gemaez Ziff. 27.1 ADSp 2017.

Bei verfuegter Lagerung im Kaeltebereich gelten zusaetzlich und vorrangig die "Allgemeinen Bedingungen der Kuehlhaeuser" (ABK), neueste Fassung.

We only work in accordance with the "Allgemeine Deutsche Spediteurbedingungen 2017" - "ADSp 2017" - (German Freight Forwarders' General Terms and Conditions 2017).

Clause 23 of the ADSp 2017 differs from the statutory liability limit for damage to goods (§ 431 HGB (German Commercial Code)). Liability for multimodal transportation, including sea carriage, in case of an unknown damage location, is limited to 2 SDR/kg and, apart from that, the standard liability of 8.33 SDR/kg is also limited to € 1.25 million per damage claim and € 2.5 million per damage event, but to not less than 2 SDR/kg. In addition to the provisions of clause 23 ADSp 2017, the following applies: Thermottraffic is not liable for damages due to loss, damage

and/or delays caused by the fault of its its servants or of the ship's company in the course of steering or otherwise operating the ship ("nautical fault"). However, this does not apply in the case of measures taken primarily in the interest of the cargo or caused by fire or explosion on board the ship. Furthermore, Thermottraffic's liability for delays occurring on the sea route is limited to three times the amount of the freight. The limitations of liability according to the previous sentences does not apply in cases of qualified fault according to clause 27.1 ADSp 2017. In case of contracted storage in cold store business, the "Allgemeine Bedingungen der Kuehlhaeuser" - "ABK" - (General Conditions of Business for Cold Stores) also apply and prevail, in their latest version.
