Following our email sent yesterday regarding Hapag's WAR RISK surcharge, we would like to inform you that Maersk has now also officially announced the implementation of a War Risk surcharge due to the ongoing situation in the Middle East.

According to the carrier's communication, this surcharge will apply to shipments involving the affected region, including cargo already in transit and upcoming bookings, in accordance with the conditions outlined in their official notice.

Below, please find the **Orbit** bookings that will be subject to this additional charge.

Please rest assured that we continue to closely monitor the situation with all carriers involved and will keep you immediately informed of any updates or changes.

Dear Customer,

Due to the escalation of security risks in the Middle East region and the effective closure of the Strait of Hormuz, vessels are currently unable to safely transit the area. As a result, service flows across the Middle East corridors have been significantly disrupted.

In order to safeguard cargo and maintain continuity of service, we have implemented contingency measures across the affected routes, including alternative routings and operational adjustments. As such, it has been necessary to implement an emergency freight increase to cover these constraints and increased operating costs.

Emergency Freight Increase

As of 02 March 2026, this freight increase will be payable by the freight paying party for all ports except Oman–Sohar. For Oman–Sohar, the increase will apply as of 03 March 2026. This means the scope of application will be:

We would like to inform you that we were in a meeting with Hapag to obtain further information regarding the application of the WAR RISK surcharge due to the recent events in the Middle East.

At the moment, the Hapag Brazil team is still awaiting further instructions and clarifications. However, according to the official communication issued by the carrier and confirmed in the meeting by the company's commercial team, the surcharge will be applied as of today to all bookings that are already in transit (on water) or scheduled for shipment.

We have reviewed our system and identified the **Orbit** bookings to which this surcharge may apply. Please find them below.

We also inform you that we continue to closely monitor the situation together with the carrier. Should there be any change in the scenario or if the surcharge is revoked, we will inform you immediately.

We remain at your disposal for any further clarification.

A **War Risk Surcharge (WRS)** for cargo to and from or via the Upper Gulf, Arabian Gulf, and Persian Gulf* will be introduced.

The dynamic situation around the Strait of Hormuz and the necessary operational adjustments are causing disruptions throughout the network, which will impact schedules and equipment supply. Therefore, a War Risk Surcharge (WRS) will take effect for cargo to and from the Upper Gulf, Persian and Arabian Gulf.

The details of this WRS are listed below and are applicable with immediate effect (excluding cargo that falls under FMC or SSE regulated scopes):

- USD 1,500 per TEU for standard containers
- USD 3,500 per container for reefer containers and special equipment

This surcharge applies to any booking issued on or after **March 2, 2026**, **all bookings already issued but which have not yet shipped**, as well as to cargo **already on the water** but not yet discharged or loaded to/from Iraq, Bahrain, Kuwait, Qatar, Oman, United Arab Emirates, Saudi Arabia (Dammam and Jubail).

For shipments within FMC scope, a War Risk Surcharge (WRS) will be introduced for cargo moving between the USA and the following
