Please note that we have been closely monitoring the Maersk platform and, at this moment, all vessels from Rio Grande to Ambarli remain closed. According to the carrier, this is due to the restriction of food-grade containers and the significant backlog of cargo in Brazil. They have informed us that there is no forecast for reopening space on these vessels, but that we should continue monitoring the Maersk platform.

Considering the current scenario, I would like to inform you that we will keep monitoring the platform and keep you updated. In case immediate shipment is required, I would also like to check if there is a possibility to proceed with another carrier for this SI.
