| MBL release: you can request to carrier ORIGINALS PRINTED AT DESTINATION (in case of extra cost, please inform us in advance, for extra cost approval) or you can SEND THE ORIGINALS BY COURIER TO OUR ADDRESS (please inform courier charge in advance for approval). |
| If originals by courier, it's very important to send as soon as vessel departed. We need to receive the physical originals at least 7 days before the vessel arrives at POD. |
