<b>MANDATORY INFORMATION AT MBL AND HBL</b>
MBL/HBL must show the Ocean Freight value as per Brazilian Customs rules.
MBL/HBL must show the same issue date (date of loading).
MBL/HBL must show goods description and NCM number. Must be identical at MBL/HBL.
Wooden package information.
MBL/HBL must be signed "by hand", not electronic signature.
MBL/ HBL: Ocean Freight must be Collect.

<b>OTHER INFORMATION</b>
Please submit the MBL & HBL drafts for approval prior to vessel departure.
Brazilian customs do not allow BL EXPRESS RELEASE, both MBL and HBL must be ORIGINALS.
MBL release: you can request to carrier ORIGINALS PRINTED AT DESTINATION (in case of extra cost, please inform us in advance, for extra cost approval) or you can SEND THE ORIGINALS BY COURIER TO OUR ADDRESS (please inform courier charge in advance for approval).
If originals by courier, it's very important to send as soon as vessel departed. We need to receive the physical originals at least 7 days before the vessel arrives at POD.
